Incidentally, if more money is pledged than is needed, contributions will then be prorated, and full reports will be rendered, from time to time, so you will know exactly how the money is spent. Payment on the pledges will probably be solicited next fall, and whoever acts as local Treasurer of the funds will be bonded.

What is your suggestion for a slogan for the Exhibition? Ponder on it a while and let us have a suggestion or two.

(Incidentally, through the co-operation of Dr. Chase, Mr. Remele is about to undertake a study of U. S. Railroad Routes and solicits the co-operation of Unit Members.) George A. Hall (RA#64) of Chicago has been exhibiting some of his historical covers; he is particularly interested in hearing from members who also collect "Postal History" of the 51-57 period.

Tracy Simpson, Ye Editor, has no doubt already mailed you your copy of Chronicle #7 - a most interesting and informative issue, judging by the previews we have had.

Ezra Cole writes that the next International Exhibition (after the London one this year) will be held in Toronto, Canada, in September, 1951, and so far as U. S. This will be a wonderful opportunity for our own 1951 Exhibition exhibitors to move their exhibits from our Philadelphia Show to the Toronto one in September.
