"OUR FIRST 1 and 3 STAMPS- FIRST TO BE ISSUED-FIRST IN BEAUTY- FIRST IN INTEREST AND FOREMOST AS A SPECIALTY"

This winning slogan was one of twenty received and was submitted by Donald M. Sturznickel (RA #121) of White Plains, New York. This is the slogan which will be featured in the central exhibit of our show and we believe our visitors will agree with its accuracy.

Paul C. Rohloff (RA #132) won first and grand prize, 19th Century Postal Markings for the second time at the 17th annual exhibition of the Austin Philatelic Club, Chicago on April 29-30.

Leo J. Shaughnessy (RA #1) won Grand Award for his Exhibition of THREE CENT 1851-57 at the convention of the Texas Philatelic Association at Corpus Christie, Texas on June 9-11. Incidentally, Leo is not the only Shaughnessy in the philatelic limelight, as Mrs. Shaughnessy (Leo J.) won second prize for her exhibit of Texas covers.

Dr. Gerald B. Smith (RA #7) and our "Travelling Ambassador of Good-Will" at the Northwest Federation of Stamp Clubs' exhibition in Portland, Oregon on May 28-30 won the Bank of California Cup for the best exhibit for an Oregon Stamp Society member for his US 19th Century; and also the Milton L. Gumbert Trophy.

Roy C. Mitchell (RA #142) won the Grand Award at SESCAL (Federated Stamp Clubs of Southern California) at Los Angeles in May.

Adolf G. Meyer (RA #71) won second prize Centenary Committee Trophy for his 19th Century US at Ferndale, Michigan at the 12th annual Peninsula State Philatelic Society exhibition. Mr. Meyer was elected Treasurer of this group.

Henry A. Meyer (RA #62) of 516 Read St., Evansville 11, Indiana who has done an outstanding job with his series of articles in the SPA Journal on "Markings of Domestic Waterways Mail", earnestly pleads for the loan of as many covers as possible bearing the markings Steam, Steamboat, Way, Ship and Water-borne Contract Route, Route Agent and R.P.O. markings. These should be not only THREE CENT 1851-57 covers, but everything from the earliest stampless down to the present time, if they fall under the above categories.
