Volume 21, October 19, 1848 - March 6, 1849, Jacob Collamer, Postmaster General

November 1, 1848

Ordered, that Commissions, as Special Agent, issue to William W. Voorhies and Isaac Brunson, under the 3rd Section of the Act of 14th August, 1848... The former for California and the latter for Oregon.

November 22, 1848

Ordered, Appoint Stephen J. Dallas, mail agent to take charge of the mails from New York to San Francisco, at the rate of \$800 per year, and pay in advance for four months services.

January 29, 1849

New York and California

Ordered, Recognize the service of St. J. Dallas as mail agent at the rate of \$800. Eight hundred dollars per year, and allow him for fifty one days One hundred and eleven dollars and seventy eight cents.

January 29, 1849

Ordered, Appoint John W. Geary, a mail agent in the service of this Department.

Volume 22, March 10, 1849 - August 25, 1849, Jacob Collamer, Postmaster General

May 17, 1849

Ordered, that Jacob B. Moore, be appointed a mail agent to take charge of the mails from the port of New York to the port of San Francisco in California at the rate of \$1000 per annum.

Volume 23, August 27, 1849 - April 12, 1850, Jacob Collamer, Postmaster General

October 24, 1849

California Mails - Bearer of Despatches.

Ordered, Allow J.H.W. Inge \$29. being expenses on Isthmus.

November 10, 1849

Foreign Mails: New York to Panama

Ordered, Appoint A. Clintock McLean, and S.A. Seymour, Government Agents for the charge and re-assortment of the mails between New York and Panama, and for the supervision of the mail conveyance across the Isthmus of Panama, and fix compensation at \$1000 per annum.

December 28, 1849

Route No 4. Extension - Panama to Chagres

Ordered, Recognize the service of conveying the mail in charge of Mail Agent A.C. McLean, across the Isthmus from Chagres to Panama at \$525 - as paid and drawn for by said A.C. McLean.

January 9, 1850

Mail Steamer Agency

Ordered, Appoint William A. Bayley, Mail Agent from New York to San Francisco at \$1000 per annum.

January 25, 1850

Routes No 3 + 4 New York to San Francisco

Ordered, Appoint B. Midgett, Government Agent for the charge and re-sortment of the United States Mails between New York and San Francisco, via Chagres and Panama.

January 31, 1850

Route No 4. Extension Panama to Chagres

Ordered, Recognize the service of conveying the mail in charge of Mail Agent A. Clinton McLean, across the Isthmus of Panama to Chagres, at \$187.50, as paid and drawn for by said A.C. McLean.

February 14, 1850

Route No. 3 New York to Chagres, S.A. Seymour, Agent

Ordered, Allow salary to draw from 19 November 1849, when his (Seymour's) service under his appointment commenced.

Allow \$150. for expenses as charged.

February 14, 1850

Route No. 3. New York to Chagres

Ordered, Recognize the service of conveying the U.S. Mail in charge of the Mail Agent S.A. Seymour, across the Isthmus of Panama, at \$592.50 for 69 bags conveyed to Panama from Chagres on the 5 February 1850 and at \$525 for 32 bags from Panama to Chagres and 15 bags from Chagres to Panama, as paid and drawn for by said S.A. Seymour.

March 5, 1850

Mail Agent; New York and San Francisco line.

Ordered, Appoint John Workman on this route at \$1000- per year.

March 16, 1850

Route No 4. Panama to Chagres

Ordered, Allow the account of James B. Devoe, at \$48.50: and refer to the Auditor for adjustment and settlement.

March 16, 1850

Route No 3 4. New York to San Francisco.

Ordered, Allow the account of WA Bayley at \$148.50 for canal (canoe) and mule hire and other expenses, across the Isthmus, on the 27 January 1850 chargeable, however, to his account until certain items of expense be more fully explained.

April 9, 1850

Ordered, Allow W.A. Bayley \$164. being the amount of his expenses occurred in crossing the Isthmus, expenses at San Diego and at San Francisco.

April 30, 1850

New York to San Francisco

Ordered, Modify order of 16" March last allowing the account of W.A. Bayley at \$148.50, by striking out the last sentence to wit, "chargeable however to his account, until certain items of expense be more fully explained".

May 11, 1850

Special Agency New York to San Francisco

Ordered, that James B. Devoe, be appointed Government Agent to take charge of the United States Mail from New York to San Francisco, in California, in the next trip of the Steamer Georgia, with the understanding, however, that he is not to claim or demand any pay or money allowance of any kind for said service.

May 11, 1850

Ordered, Allow the account of John Workman, for expenses incurred in charge of the U.S. Mails across the Isthmus of Panama between 27 March and 27 April '50, both inclusive, at \$162. and refer to Auditor for adjustment.

May 15, 1850

Panama to Chagres

Ordered, Recognize the service performed by Matthew McLaughlin, as agent in charge of the U.S. Mail from Panama to Chagres on the 8" February 1850, at \$80; and refer to the Auditor to pay the draft, drawn upon the Department by AB Corwine, in favor of said McLaughlin, for that amount.

May 27, 1850

New York to San Francisco

Ordered, Allow the account of W.A. Bayley, at \$184.50, expenses incurred in charge of the U.S. Mails across the Isthmus between the 24 and 27 April last, and refer to the Auditor for adjustment and settlement.

June 4, 1850

California Mails

Ordered, Allow the account of A. Clinton McLean, at \$173 expenses occurred in charge of the U.S. Mails across the Isthmus between 20 February and 3 March and between the 10 April and 13 May 1850, and refer to Auditor for adjustment and settlement.

June 17, 1850

Route No 3 + 4 New York to San Francisco

Ordered, Allow the account of B. Midgett, at \$216.65 expenses incurred upon the Isthmus, in charge of the U.S. Mail including 37 days per diem upon the Isthmus and at San Francisco, and refer to the Auditor for adjustment and settlement, charging B. Midgett, with the amount of postage received for paid letters as per account within.

June 18, 1850

New York to San Francisco

Ordered, Allow the account of S.A. Seymour, at \$126 - expenses incurred upon the Isthmus in charge of the U.S. Mail including 17 days per diem - upon said Isthmus and at San Francisco between the 28th February and 12 June 1850, and refer to the Auditor for adjustment and settlement.

June 19, 1850

New York to San Francisco

Ordered, Allow R.J. Laurenton \$99.45 expenses incurred upon the Isthmus, in charge of the U.S. Mail including 14 1/2 days per diem upon the Isthmus and also including \$25.45 allowed him additional for difference between his salary and that of Government Agent, which duty he performed, from the 28th April to 10 June both inclusive, 45 days.

June 20, 1850

New York to San Francisco

Ordered, Credit the PM of San Francisco with \$300: the amount advanced to S.A. Seymour, Government Agent, to defray the expense of his fare to Panama from San Francisco, two agents having been thrown together at San Francisco in April last, in consequence of a failure to connect at Panama with the regular boat of the first of March, and Contractors refusing to take more than one agent without pay.

June 26, 1850

New York to San Francisco

Ordered, Allow B. Midgett, Government Agent \$26 per annum for 13 days, between 10th and 22nd June, both dates included, having repaired to Washington, under orders of the Department, and refer to the Auditor to adjust.

June 27, 1850

New York to San Francisco

Ordered, Allow the account of James B. Devoe, temporary Government Agent, in charge of the California mails, from New York, on 13 May 1850, at \$70.21 (being \$28. less for canoe and mule hire of servant) But protect the draft at whole amount to wit: \$98.21

July 22, 1850

New York to San Francisco

Ordered, Allow the account of W.A. Bayley, for expenses incurred in charge of the U.S. Mails across the Isthmus of Panama between the 20th + 26th June 1850, both inclusive and 13 days per diem at San Francisco, at \$134 - and refer to Auditor for adjustment.

Routes No 3 + 4 New York to San Francisco

Ordered, Allow the account of John Workman for expenses incurred in charge of the U.S. Mail across the Isthmus of Panama between the 9th and 26th June 1850, both inclusive, at \$198, and refer to the Auditor for adjustment.

Allow the additional \$6. paid for transporting mails at Cruces and Panama.

August 21, 1850

No 3 + 4 New York to San Francisco: Mail Agency

Ordered, Appoint William Whitney, Government Agent for the charge and re-assortment of the U.S. Mails between New York and San Francisco, via Chagres + Panama at \$1000 per annum.

August 23, 1850

Routes 3 + 4 New York to California

Ordered, Allow the account of \$72. expenses incurred by W. Van Voorhies, the Special Agent for California, in charge of the United States Mail across the Isthmus of Panama, between the 28th and 31 December 1848: provided the items of expense have not been already allowed in a former account.

August 30, 1850

Routes 3 + 4 New York to San Francisco

Ordered, Allow the account of S.A. Seymour, at \$100. expenses incurred upon the Isthmus in charge of the mails and thirty two days per diem at \$2. per day between the 12 July and the 12 August 1850, both inclusive, and refer to Auditor for adjustment and settlement.

September 4, 1850

New York to Chagres and Panama

Ordered, Appoint John S. Wescott, assistant Mail Agent from New York to Panama for the next trip commencing 11 instant on condition that there be no charge for compensation or any additional expense whatever against this Department therefor.

September 23, 1850

New York to San Francisco

Ordered, Allow the account of A. Clinton McLean, for expenses incurred in charge of the U.S. Mails across the Isthmus of Panama, between the 25th of June and 2nd July 1850, and between the 22nd and 25th August 1850, at the amount below stated (241 dollars) embracing 18 days per diem at Chagres and San Francisco as per account.

Route No. 3. New York to Chagres

Ordered, Recognize the payment of fare from Chagres to New York at \$100 (for which draft was given on the Postmaster General) as part of the expenses of R.J. Laurenson U.S. Mail Agent (temporary) on the Panama route in May last and refer to Auditor to pay said draft: to be charged to Laurenson until voucher is produced or other evidence to justify credit of the same.

October 1, 1850

Routes No. 3 & 4. New York to San Francisco

Ordered, In view of the employment of the sub-agent, and the advances made to him by Mr Bailey, to defray his necessary expenses-
Allow an advance to W.A. Bayley, agent & of \$150.

October 11, 1850

New York to San Francisco - Agency

Ordered, Allow the account of B. Midgett, Agent, at \$201:- expenses incurred in charge of the U.S. Mails upon the Isthmus including twenty seven days per diem upon the Isthmus and also at San Francisco between 24 July and 25 September, 1850, and refer to the Auditor for settlement and adjustment, charging B. Midgett for paid letters as per account rendered.

October 30, 1850

Routes No. 3 & 4 New York to San Francisco

Ordered, Allow the account of William Whitney, Government Agent for the expenses incurred in charge of the U.S. Mails across the Isthmus between the 8th September and 11 October 1850, both dates inclusive, embracing 34 days per diem at \$2 per day together at \$248, subject to a deduction of \$6 for postages received, and the further amount of \$29.75, the amount of items marked in the account for further explanation, and refer to the Auditor for adjustment and payment.

November 6, 1850

Routes No. 3 & 4 New York to San Francisco

Ordered, Allow the account of Daniel Norcross, at \$61.80, for mule hire for himself and baggage, and other expenses incurred upon the Isthmus in charge of the U.S. Mails between the 4 and 12 of

January 23, 1851

Ordered, that Randolph M. Cooley, of the City of New York, is hereby appointed Assistant Mail Agent, to proceed with the mails from New York to San Francisco, via Havana and Panama, on the 11"

In the event no one of the agents, heretofore appointed to take charge of said mails, shall be in readiness to proceed with them on the said 11th of February next, Mr. Cooley will proceed with such mails, with the usual right of passage.

January 28, 1851 California Mails

Ordered, Recognize service (stated in case) and refer to Auditor to credit William Haydon, late PM of Boston, to full extent of claim (\$1011) on the presentation of proper voucher, if in the opinion of the Auditor there is nothing in the law against such allowance. If there is not authority of law to allow and pay the account the Auditor will report accordingly, that the matter may be presented to Congress.

January 31, 1851 New York to San Francisco - over No 3/4. Route Agency
Ordered, Allow the account of B. The \$150. advance to be deducted.

April 8, 1851
