The F. | 42 marking refers to Article 42 of the 1866 Franco-Thurn & Taxis Convention, under which unpaid letters from the U.S. through France to Thurn & Taxis were accounted.

T.F. means "Transit Français." Entered France at Strasbourg on 14 December 1858, where BADE STRASB. / AMB. D applied.

6/37 shows Thurn & Taxis division of 43 kr payment between internal and foreign portion. Transit to French border was 6 kr per loth for 10-20 miles and 9 kr per loth over 20 miles (about 16.5 grams per loth).

Foreign portion credited to France for a double letter (between 4/20 and 9/20 loth) was 37 kr. Letter entered France at Forbach, where TOUR. T / 3 FORBACH 3 applied. Rated as double in France (probably 7.5 grams).



1849 U.S.-British Treaty / 1856 Anglo-French Convention: New Orleans 14 December 1856 to Augsburg, Bavaria, by *Africa* (Cunard Line), New York 24 December 1856, Liverpool 4 January 1857
First sailing during "Three Month Period" rates under new 1856 Anglo-French Convention and before 1857 U.S.-French Convention (1 January 1857 to 1 April 1857). England forwarded mail to France at 2 Francs Per Kilogram. 7 kr due.





1857 U.S.-French Convention: 2¢ circular rate prepaid from New Orleans 7 February 1859 to Schopfheim, Baden, by New York (North German Lloyd Line), New York 19 February 1859, Southampton 3 March 1859.

5 kr due (4 kr French, 1 kr Baden).

Effective 1 January 1868, the U.S. entered into a convention with the recently formed Northern German Union. The direct rate via Bremen or Hamburg was reduced to 10¢ (4 sgr or 14 kr) and the closed mail rate via England was reduced to 15¢ (6 sgr or 21 kr).



This Convention added Boston as an exchange office for direct mail.

14 kr (10¢) rate prepaid from Kehl, Baden, 1 February 1870 to Washington, D.C., by *Main* (North German Lloyd Line), Bremen 5 February 1870, New York 19 February 1870. From the U.S. consulate Strasbourg, France. Carried across the Rhine and mailed from Kehl, Baden. 3 sgr foreign postage marked.

Prepayment was optional, but Article VII imposed a 5¢ or 2 sgr penalty if unpaid or insufficiently paid. The penalty was not increased for double rate letters.





Single 10¢ rate insufficiently paid from Blountsville, Tennessee, 6 June 1870 to Berlin, Prussia, by Weser II (North German Lloyd Line), New York 11 June 1870, Bremen 23 June 1870.





Rare example of a U.S. marking that converts the deficiency to a foreign currency.

Double 10¢ rate insufficiently paid from New York 26 March 1870 to Harpstedt, Hanover, by *Deutschland* (North German Lloyd Line), New York 26 March 1870, Bremen 10 April 1870. *Hansa* was advertised to carry mail, but letter sent on *Deutschland*.



1 sgr circular rate paid from Bremen 28 February 1868 to Philadelphia
 by Hermann (North German Lioyd Line), Bremen 29 February 1868, New York 4 March 1868.
 This circular announced the North German Lloyd Line's new service between Bremen and Baltimore that began 1 March 1868. This line connected with the Baltimore and Ohio Railroad, which financed half the cost of the first two new ships that would provide the transatlantic service.
