Cross-Border Mail via the Cunard Line: Mail Carried Between the United States and Halifax, 1840-1867

Purpose:

This exhibit illustrates postage rates for mail carried between the United States and Halifax, Nova Scotia, by steamships of the British & North American Royal Mail Steam Packet Company, better known as the Cunard Line.

Importance:

Cunard Line steamships provided reliable, scheduled service between Halifax and the United States. The steamship route was favored by merchants because it was much faster than the overland route, and prior to 1851, was significantly less expensive. The exhibit illustrates the complex and poorly understood rates that were never subject to a postal treaty.

Scope:

From 1840 through 1867, Cunard Line steamships stopped in Halifax, *en route* between Boston and Liverpool. Cunard Line steamers to New York City also served Halifax between January 1848 and September 1850. Cunard Line mail between the United States and Halifax was never covered by postal treaty. As a result, letters could not be paid to destination, and include separate United States and British North American rates. The packet postage rates were set by the United Kingdom and were always paid by the correspondent in British North America.

Organization:

The exhibit is arranged chronologically, first illustrating the rate periods described at right for letters between the United States and Nova Scotia (pages 2-11), followed by the special closed mail rates to Canada via Boston (page 12), rates to or from Newfoundland (pages 13-15), Prince Edward Island, and St. Pierre et Miquelon (page 16).

Large part folded address sheet, only reported use of a postmaster provisional on packet cover to Halifax, and only reported use to Nova Scotia.

Halifax — New York 30 October 1848

NS — Paid 1 shilling sterling packet postage per *Hibernia* to Boston US — 29¢ due: 5¢ for distance under 300 miles, plus 24¢ American packet postage

From June 27, 1848 to January 3, 1849, United States charges American packet postage on prepaid letters by British packet, including letters from Halifax.



Halifax — New York 23 December 1848

NS — Paid 1 shilling sterling packet postage per Europa to New York

US — 24¢ due American packet postage

Last sailing from Halifax during retaliatory period. Cunard Line packets between Liverpool and New York serve Halifax between January 1848 and September 1850.

US Treaty Rate to Canada—10¢ (6d currency) due

Only open-mail packet pence issue cover to Canada. Total postage of 11d versus 7½d if sent by closed mail or 3d if sent by land mail.

NS—6d dark green 1857 and pair 1d red brown 1853s pay 8d currency rate: 5d currency (4d sterling) packet rate per *America*, plus 3d inland (mailed before cents issue was available) US postage—5¢ due

5 packet covers reported paying the 8d rate with pence issue stamps, this being the only cover with the 6d dark green.




Halifax—Baltimore 18 February 1861

NS —8½¢ green 1860 pays packet postage (4d sterling) per *America* US—5¢ due equal to British Open Mail rate

The 81/2¢ packet rate was in effect for only nineteen months after the stamp was issued.





15 October 1861

US—5¢ buff 1861 pays rate equal to British Open Mail rate NS—5d currency (8½¢ [4d sterling]) due packet postage per *Niagara*

Halifax continued to use the 5d rate marking during the $8\frac{1}{2}$ ¢ rate period.

One of four Nova Scotia pence issue covers paying the exact rate, and the only cover with a 6d dark green.

Minor repair to bisect.

BNA —12½¢ yellow green 1859 pays 8½¢ (4d sterling) packet postage per *Africa* via Boston plus special 4¢ (2½d sterling) inland rate

One of 11 recorded Canada decimal issue covers paying the closed mail rate.

Boston - Summerside, Prince Edward Island

US—3¢ rose 1857 Type I underpays 5¢ rate equal to British Open Mail rate BNA—9d currency due: 6d Prince Edward Island currency (4d sterling) packet postage per *Europa*, plus 3d currency inland

Prince Edward Island currency had greater depreciation against sterling than Nova Scotia.

Foreign Mail: Saint Pierre et Miquelon

US - paid 5¢ equal to the British Open Mail Rate

NS —10d cy: 5d currency (4d sterling) per *Europa* to Halifax plus 5d currency (4d sterling) per Cunard feeder route to North Sydney, Cape Breton Island, Nova Scotia

SPM postage—1.25 franc, 10d Nova Scotia postage due converted to 1 franc, plus 25 centimes for French packet from North Sydney to Saint Pierre
