

LINCOLN DEFINITIVE 4¢ & 5¢ ISSUES OF 1890-1908

The four cent Abraham Lincoln stamps were first issued in 1890. Originally printed under contract with the American Bank Note Company, the new stamps were of a smaller size that corresponded to other values of the regular issue as well as the typical British stamps in circulation.

In September 1894, the Bureau of Printing and Engraving (BEP) was awarded the printing contract. The master die was altered with the addition of triangles in the upper corners and other minor changes before new plates were prepared. The stamps were printed on paper without a watermark.

On June 5, 1895, the BEP switched the stamp paper and began using paper bearing a double-line "USPS" watermark in each stamp position.

On October 7, 1898, the stamp color was altered to alleviate the plate wear problem. The new stamps were printed in shades of rose-brown, lilac-brown, and orange-brown. The colors used for the other denominations were altered at the same time to conform with the new provisions of the Universal Postal Union.

On January 20, 1903, the BEP issued the new five cents Lincoln design in blue as part of the definitive issue begun in 1902. The stamps bear the double lined "USPS" watermark.

On February 24, 1908, the stamp was issued as an endwise coil, perforated horizontally. The 1908 coils were the first issued by the government.

On May 30, 1908, the stamp was issued imperforate. Only 13,200 were issued imperforate and most of these went to manufacturers of private vending machine coils.



21 February 1898 Binghamton N.Y. to Mexico City, Mexico prepaid 5¢ UPU rate in combination with 1¢ 1895 issue. Letter forwarded to Cuba and then returned to sender.



31 December 1896 New Orleans La. to Tegucigalpa, Honduras, prepaid with pair in combination with 2¢ 1895 issue for double the 5¢ UPU rate.

1898 Issue - Four Cents

On October 7, 1898, the stamp color was altered to alleviate the plate wear problem. The new stamps were printed in shades of rose-brown, lilac-brown, and orange-brown. The colors used for the other denominations were altered at the same time to conform with the new provisions of the UPU.

In 1899, the P.O.D. overprinted stamps "Guam" for use while the post office there was under jurisdiction of the Navy Department from July 7, 1899 until March 29, 1901, when the P.O.D. took control. On August 30, 1901, the P.O.D. overprinted the 4¢ values "Philippines" for use under American Administration of the islands.






